America was not going to counter strike that fast".

"Non-performing MPs: Blame the Electorate", Dr. Nyinguro was quoted in an interview in which he blamed the ordinary citizens for not playing their part to "make democracy work". He deplored the political apathy and lack

of a sense of civic responsibility on the part of citizens.

Moreover, "the power sharing deal that bore the coalition government was not based on principles like say in Germany and the UK but on a disputed election", He also blamed the wrangles in the grand coalition on the "lack of a shared vision".

Sunday June 27, 2010

The Standard on Sunday (Kenya) on page 2 quotes Dr. Nyinguro as saying in an interview with The Standard that Uhuru, Minister for Finance, was "not resolute and does not know how to play national politics.. His abandonment of the independence party at a time he was leader of the opposition to join President Kibaki's party of National Unity in 2007 is a sore mark in his history and a pointer he is a desperate politician who can sacrifice democratic ideals for tribal interests.
